

## **Campsite regulations**

Dear camping guest!

Welcome to the Toodlermillen campsite! We are pleased that you will spending your holiday with us. Please find hereafter some tips and requests to make your and all other guests' holiday as pleasant and trouble-free as possible.

- 1) Please report directly to the reception upon arrival so that you can be properly registered.
- 2) On the day of departure, the pitch must be left clean by 12 noon at the latest.
- 3) The allocated pitch is only intended for one visitor unit (motorhome, caravan, or tent). Small additional tents (2-person igloos) may be pitched in exceptional cases - prior permission required!
- 4) Facilities and equipment are expensive and should (like your property) be used carefully. Do not tear or cut branches or twigs from trees and bushes.
- 5) It is not permitted to border the pitches with ditches and fencing. Always make sure that nobody is endangered or disturbed by tent pegs, tent lines and other tent accessories.
- 6) Barbecue only with stand equipment approved for this purpose. Disposable barbecues, open fires and fires on the ground are prohibited.
- 7) It is forbidden to pitch party tents or sun protection tents on the entire grass beach along the river.
- 8) The campsite is closed from 22.00 to 08.00 hours. During this time, our barrier is closed, and you cannot enter the campsite. Please set the radio, TV, and similar devices to tent volume. In the interest of our guests, we kindly ask you to avoid loud entertainment and disturbing noise during this time. Please do not play football in the fields, the playground or beach is provided for this purpose.
- 9) Driving with vehicles of all kinds is only permitted on the designated paths at walking speed (speed limit 10 km/h), pedestrians have priority.
- 10) The washing of vehicles of all kinds is prohibited (abuse of drinking water!)
- 11) The exercise of any trade on or from the campsite, as well as exhibitions on the site, require the authorisation of the administration.
- 12) Please dispose of your waste sorted at the recycling site. The containers are marked. We do not accept bulky and problematic waste; this can be disposed of at the municipal recycling centre. Please note that waste disposal and emptying chemical toilets is the responsibility of adults.
- 13) We attach great importance to order and cleanliness and carry out constant checks of all facilities. Please leave the sanitary facilities in perfect condition. Smoking is not allowed in the sanitary facilities. Under no circumstances should you throw rubbish in the toilets, use the containers for this purpose. Please note for safety reasons, children under 4 years of age must be accompanied by an adult when entering the sanitary facilities and toilets. Their behaviour and clothing must be correct both on the premises and in the sanitary facilities.
- 14) Water is very precious. Please use it sparingly and inform your children about this. Use detergent sparsely and avoid using fabric softeners in washing machines.
- 15) The wastewater from your portable toilet can be easily emptied into the chemical toilet drain. Please use only sewage-friendly sanitary additives. Never allow sewage to seep into the ground and never dispose of it directly into the rainwater drainage system!
- 16) Each power connection assigned to the stand is equipped with a residual current circuit breaker (Fi-switch). Please unwind cable drums completely.
- 17) Pets are welcome, please register them at the reception on arrival. Within the campsite, dogs must always be kept on a leash. They may not be taken into the sanitary facilities. Outside the campsite there are plenty of opportunities to run out. However, please make sure that your dog does not exercise its distress call on the camping site, paths, or meadows. Please dispose of them with dog bags.
- 18) The Keiser family accepts no liability for damage or loss incurred by the tenant, his relatives, and visitors. Anything else is only valid in case of intentional or grossly negligent behaviour of the landlord or his employees.
- 19) The instructions of the administration or the field service are binding. This applies to the installation of motor vehicles, caravans, tents, and similar facilities. The Keiser family is entitled, in the exercise of domestic authority, to refuse to admit persons or to expel them from the site if this appears necessary to maintain safety and order on the campsite and in the interest of the other campers. Anyone who grossly violates the provisions of these campsite regulations must expect immediate expulsion.
- 20) Should a case of damage (e.g. water leakage) occur to communal facilities, please report this to the reception desk.
- 21) Please report emergencies (accidents, illnesses, etc.) immediately at the reception, we will inform the emergency service for you if necessary.

Please help us to keep improving. Your suggestions for enhancement of the campsite are important to us. More minds - more ideas. Let us know in writing about feasible suggestions for improvement. The reception staff will be happy to answer any questions you may have regarding the operation of the campsite at any time. Please also note the current information on the notices.
